



Pennsylvania (PARA) Alpine Officials 2012-2013 Report

Ski Racing Season Highlights:

The 2012-2013 Alpine Ski racing season in PA was one of monumental change. Some of this year's changes include; the age classification changes, a variety of new rules, new course setting procedures, renewed emphasis on security of the competitor and a very compressed race schedule, due to a late start; dictated by the weather. However, once the season did start, at least the weather cooperated.

Many changes kept this year's racing season interesting. The Interdiction rule was the topic of many pre-race gatherings. The long and short of it was... "the rule is hard to explain"; but, "you know it when you see it!" Our certified gatekeeper program, championed by Bill Filling, prepared the gate keepers for this rule change as well as single gate GS. PARA's certified gatekeeping program has continued to grow; and has helped to bring consistency to this very important and fundamental task in alpine ski racing. All ROC's have increasingly made use of these certified gatekeepers providing them with the added incentive of an extra lift ticket for their gate judging service. This incentive of an additional lift ticket has been extended to Jury advisors at many of the races held this year; especially at the state-wide races.

PARA also choose to enforce the Interdiction rule for all USSA races (scored & un-scored) to simplify the gatekeepers duties and to alleviate the ambiguity of when U16's could hike in GS and when they couldn't. A vote and passage of the PARA BOD prior to the first AO updates was conducted, and then the racing community was notified and updated on this exception to the USSA adopted rule. A concerted effort to fully educate and communicate this change **worked well** with no negative consequences regarding the PARA decision to enforce the Interdiction rule for all USSA races.

In general, all of this year's AO updates included an in depth discussion of the Interdiction rule and what constitutes a legal pass in a single gate/pole race course. The renewed emphasis on the provisional rerun procedure was yet another avenue for discussion.

Changes in The USSA age classifications and the renaming of these race classifications using a "U" designation with an associated age also took some time to become familiar with. It took half the year for most of us to make the shift from using the "J" designation to the "U" designation without thinking about it.

This year's USSA course setting guidelines for un-scored competitors no longer allows for an ROC to run scored and un-scored competitors on the same course. This added to the complexity of running events. The fencing requirements especially at the GS venues for security of the competitors continue to grow exponentially. No



longer do Juries rely on the homologation report to satisfy this security of the competitor; we are moving toward fencing and in some cases double fencing most, if not all, of the course. The good-news is that it has significantly cut-down on athlete injuries. Equipment rules that changed in mid-season (exp. Helmets) also kept our Alpine officials on their toes. The concussion protocol and associated competitor listing instituted last year by USSA continue to have growing-pains... I could go on and on but as usual the PARA alpine officials were up to the task and performed their usual exemplary work.

Once again, the ranks of Active PARA's Technical Delegates have decreased. Currently, we have 14 active TD's. There are 123 certified jury advisors/referees in PARA. Our overall number of Alpine Officials in PARA total - 299; most of these AO's have at least 1 certification and 14 alpine officials have all nine specialty certifications.

Yes I will say it once again... We have a dedicated alpine official community in Pennsylvania, and I am very proud and honored to represent them. Thank you and know this that without you, there would be no ski racing in PARA.

Educational Opportunities:

PARA provided four general Alpine Officials workshops, geographically dispersed throughout the state. They were held at Roundtop, Wisp, Jack Frost, and Tussey Mountain (79 participants attended). One of the workshops was sponsored by the Eastern Alpine Official's (EAO) organization and Dirk Gowens presented the workshop. John McGregor and I jointly performed the AO update at Jack Frost. John also conducted a workshop at Wisp and I performed the Tussey Mountain workshop.

I continue to host the PARA AO Website <http://scis.nova.edu/~rlipton/para/default.htm>. The Alpine Officials community uses this website to retrieve the most recent versions of all USSA forms and documents and to find out about other pertinent updates, rule changes, clarifications and other timely information useful to our AO community. I continue to use a Google doc to schedule the Technical Delegates and Referees for this year's races. TD's have editing rights and everyone else has Read access to the schedule.
