Membership Levels

Overall Membership

The overall PARA Membership level saw an increase from 2014/15 to the 2015/16 season. The increase is primarily represented by the new USSA Category "Alpine General"

2011/12 - 1215 total members 2012/13 - 1183 total members 2013/14 – 1197 total members 2014/15 – 1218 total members 2015/16 – 1345 total members





By Month Membership Signup




USSA Licensing Comparison

- U10 had a 25% increase
- U12 had a 8% decrease
- U14 had a 2% decrease
- U16 had a 7% increase
- Membership change from U18 to U19 had a 4% increase
- U18/U21 (2015) vs U19/U21 (2016) was a 5% decrease

Membership Attrition Year over Year

5-year Attrition Trend in USSA Alpine Membership

The attrition rates from U14 up are staggering.

USSA membership figures especially from the last two seasons (FY14 and FY15) show an increase in attrition as athletes move from the U16 to U18 ages jumping to 34% and 37% respectively, while other years and age group jumps average out to approximately 30%. For the last three seasons (FY13-FY15) the attrition as athletes move from U18 to U21 jumped sharply to 39%, 40% and 41%. There is a gap between high school and college participation and the transition to masters or club league racing.

Quota percentages remained relatively the same however the number of participants in PA Championships was reduced due to the reduction in the field size.

PARA Membership 2015/2016 Season

In the event that the actual value calculated from the percentage of the population falls below the minimum number or above the maximum number designated, that minimum or maximum number shall be used for the field size. U16s:

The total number of athletes invited to the U16 Derby would be 50% percent of the PARA membership in the U16 age class, with a minimum of 65 athletes plus 5 discretionary and a maximum 90 including 5 discretionary.

U14s:

The total number of athletes invited to the U14 Derby would be 40% percent of the PARA membership in the U14 age class, with a minimum of 65 athletes plus 5 discretionary and a maximum 90 including 5 discretionary.

U12s:

The total number of athletes invited to the U12 Derby would be 40% percent of the PARA membership in the U12 age class, with a minimum of 65 athletes plus 5 discretionary and a maximum 90 including 5 discretionary

Looking Ahead

- 1. USSA Dues Management fees will continue at 5% service fees for registration. With the BOD confirmation an increase in the membership rates for the 2016/17 season will not be pursued, we have confirmed to USSA the same rate structure as in previous years
- 2. Institution of USSA Direct Deposit. USSA offered payment for your division or state dues by direct deposit for those interested. Instituted in the 2014/2015 season and has cut down the time in which funds are transferred from USSA to PARA.
- 3. New USSA pricing and categories in 2015/16 increased the overall PARA Membership base essentially by creating the new Alpine General category. From a PARA perspective, do we need to address this group with any special focus (training programs??)?
