

# B-NETTING MATCHING GRANT CHAIR REPORT 2023-2024

For 2023-24 season, PARA awarded \$5,320 in matching grants to clubs to support their B-net purchases. Clubs awarded PARA grants also leveraged another \$6,250 in additional matching grants from the Kelley Brush Foundation. **KBF's deadline this year is June 28, 2024.** 

This year was the first time that matching grant requests from clubs exceeded the PARA program budget. Clubs requested a total of \$7,320 from PARA, and the Directors approved a budget of \$4,000 (a reduction from the \$6,000 approved in prior years).

Elk won a KBF grant and requested \$2,000 from PARA after all of the budgeted funds were allocated. The Executive Committee agreed to delay payment of the match for Elk until the coming season.

A such, the Netting Chair recommends that PARA change the application process from the current rolling, and first-come/first-served application process to one with specific application deadlines, and that we restore the program funding to \$6,000. A motion to make the above changes is attached.

This was the 9<sup>th</sup> year of the PARA Ski Racing Safety Matching Grants Initiative, and the program has been very successful. PARA has spent roughly \$18,000 over 9 years and that has resulted in roughly \$80,000 in B-netting purchased — a more than 3.5x leveraging of PARA funds.

The program further leverages club and PARA resources, as clubs are eligible for special discounted KBF pricing on the nets when they are awarded a KBF grant. Nine of the twelve times PARA awarded a club a grant, that club also applied for and won KBF funds.

#### **Background:**

In 2015, PARA implemented a grant program to provide matching funds for ski racing safety equipment (i.e. B-nets, etc.) for clubs who apply to the program and meet specific funding criteria. Grants are paid directly to the vendor supplying the nets after the club pays its portion of the funds (following the KBF model). # PROPOSAL TO RESTRUCTURE THE AWARDS PROCESS FOR THE B-NETTING MATCHING GRANT INITAITIVE

## **Summary:**

- To restructure the PARA application process for the B-Netting Matching Grant Initiative so
  as to give a priority to those clubs that also commit to apply for a Kelly Brush Foundation
  (KBF) matching grant that same year, and
- To restore the program funding to the \$6,000 per year. Elk already has already submitted a request for \$2,000 from the prior season which PARA did not award due to the budget limitations.

The goal of the first change is to ensure that clubs applying to KBF actually request that KBF match the *combined amount* of funds provided by *both PARA and those from the club* so as to quadruple limited PARA funding (i.e. \$2,000 from the club is matched by \$2,000 from PARA, and the club asks KBF to match that combined amount with another \$4,000.)

### **Motion:**

Specifically, to change PARA's current rolling and first-come-first served application process to two funding rounds with specific application deadlines for each round.

Round 1 applications would be due to the Executive Committee before the June KBF application deadline each year.

Round 1 awards by PARA would be conditional on successful award of a KBF grant that matches the combined total of both the club and PARA funds (not just matching the club funds).

Club applications to the Executive Committee would be required to specify the following:

- Total dollar value the of netting or safety equipment to be purchased at KBF pricing;
- Amount of funds to be provided by the club;
- Match requested from PARA; and
- Amount the club intends to request from KBF (i.e. double the two amounts above);

Round 2: applications would be due September 30<sup>th</sup> (after KBF award decisions are made); and would be subject to PARA funds remaining after Round 1 awards are made.

The Executive Committee will announce the application deadlines for Round 1 by no later than the Spring Meeting each year. For the 2024-25 budget year, the Round 1 application deadline would be [COB Friday 5/25/24 with Exec Comm decisions communicated to clubs by 6/3/24]. **KBF's deadline this year is June 28, 2024.**
